A renewal of a tax for the benefit of Boston Heights Village for the purpose of providing and maintaining fire apparatus, appliances, buildings and sites at a rate not exceeding 0.5 mill for each one dollar of valuation, which amounts to 5 cents for each one hundred dollars of valuation, for 5 years, commencing in 2014, first due in calendar year 2015.
