


Waiver of Declaration of Filing-Day Finances

Prescribed by Secretary of State 9/99

Due: not later than seven days after the petition filing deadline.

Any candidate who does not file this waiver must file a Declaration of Filing-Day Finances not later than seven days after the petition filing deadline.

The Friends of Joe Vassel (Committee's name) campaign committee established for the candidacy of

Joseph Vassel (Candidate's name) who is seeking the office of General Assembly 35th District (Office sought; if general assembly, or state board of education include district)

to appear on the ballot in the year 2016 attests that:

- 1) the campaign committee did not accept any aggregate contribution from a contributor in excess of the limits provided in R.C. 3517.102 during the pre-filing period as defined in R.C. 3517.109; and
- 2) the campaign committee had less than the carry-in amount in cash on hand at the beginning of the pre-filing period, if applicable. (House candidates \$35,000, Senate candidates \$100,000 and statewide candidates \$200,000.)

Therefore the undersigned attests that the campaign committee is not required to file a Declaration of Filing-Day Finances.

This statement made under the penalty of election falsification. Whoever commits election falsification is guilty of a felony of the fifth degree.
